However, this sentence was later quashed, after a ruling from judges including Justice Leveson gave him a determinate 16-year jail term, meaning he could be automatically released after eight years, half of his sentence... [Source](#)

One of the heroes of yesterday's [London](#) Bridge attack is a convicted murderer out on day release, it has emerged.

It is believed James Ford rushed to the scene and tried to save the life of a woman victim of the terrorist. Now 42, Ford was jailed for life – with a minimum of 15 years – in April 2004 for the murder of a 21-year-old with learning difficulties.

Amanda Champion – who had the mental age of a 15-year-old – was found strangled and with her throat cut on waste ground near her home in Ashford, Kent, the previous July... [Source](#)

A serial rapist attacked 11 victims in a two-week rampage after being freed from prison by mistake.

Joseph McCann, 34, was yesterday found guilty of kidnapping, raping and sexually assaulting women and children aged between 11 and 71.

He snatched some victims off the street, forcing them into his car at knifepoint.

He should never have been at liberty to commit the vile crimes and the head of the prison service yesterday apologised unreservedly for the catastrophic error.

McCann was freed automatically from jail in February – halfway through a three-year sentence. The decision to release him should instead have been made after consideration by the Parole Board.

This was because he was on lifelong licence for an aggravated burglary in 2007.
