How a Labour MP and his family are raking in £300,000 from taxpayer

A LABOUR MP and members of his family who work in the party are costing taxpayers £300,000 a ear, it is claimed.

Tom Watson's wife, brother, sister-in-law and cousin are all employed by the party. Gordon Brown's trusted ally represents West Bromwich East,

ne of the most deprived local athorities in the country. Yet it is claimed that between

them the Watsons rake in more than £300,000 a year in salaries. Mr Watson, 41, nicknamed Tommy Two Dinners, has been the larger than-life MP for West Bromwich East since 2001.

He was a Government whip from 2004 to 2006 and then a unior defence minister.

But he resigned after staging an unsuccessful coup to force the then Prime Minister, Tony Blair, to stand down. Mr Watson was restored to ministerial office after Mr Blair

onit. He was appointed Cabinet
Office Minister in January.
He has been tipped for even

higher office and is well liked by his constituents in one of two Labour-held seats in Sandwell in the Black Country.

Deprived

Sandwell, one of the most deprived council areas in the country, consistently comes close to the bottom of league tables for poor health, exam results, housing and joblessness.

The MP has also earned himand the MP has also earned him-self a reputation in the Labour party for his Tory-taunting post-ings on his website. He is credit-ed with being Britain's first MP to start an internet blog.

In 2006-'07, the latest year for which figures are available, Mr Watson earned an MP's basic salary of almost £60,000

But his Parliamentary expenses were £150,000, bringing his total package to £210,000. His annual expenses were the sec-

aminal expenses were the sec-ond-highest among MPs in the West Midlands, topped only by Liam Byrne, Labour MP for Birmingham Hodge Hill and the Minister for the West Midlands.

MPs of all parties consistently point out that many expenses they receive are not an additional salary but go on support staff, services or essential equipment.

Mr Watson's wife Siobhan works in his constituency office in West Bromwich and is paid up to £20,000 a year.

His brother Dan is constituency director to Euro MP Michael Cashman, the gay activist and former EastEnders actor, and he is earning an estimated £25,000 a

Dan Watson's wife Joanna has three jobs. Like her husband,

she works for Mr Cashman and for the Wolverhampton Labour MP Pat McFadden - yet still finds time to be a Labour coun-cillor in Sandwell.

It is unclear how much her obs bring in but they are elieved to earn her more than

£30,000 annually.

Amy Watson, cousin of Tom and Dan, earns about £21,000 a year working for Birmingham Northfield Labour MP Richard family. But I do not employ them and I have no idea how much each of them earns.

"I provide a fully comprehensive, hard-working service for all my constituents. Who other MPs

employ is a matter for them.
"What is important is that we provide an excellent service for my constituents. I think we pass the test."
